Unfulfilled BCBS239 objectives

In July 2023, ECB shared a consultation regarding prerequisites of **Risk Data Aggregation and Risk** Reporting. This consultation follows weaknesses identified by the Supervisory Review and Evaluation Process (SREP).

- > Key deficiencies on the governance arrangements
- > Low effectiveness on risk data architectures
- > Lack of supporting IT architecture



Encourage organizations to implement rapidly improvement and compliance plans. Set up and develop the best practices on risk data management, governance and guality.

7 PRINCIPLES TO IDENTIFY, MONITOR AND REPORT RISKS WITH ROBUST AND **EFFECTIVENESS GOVERNANCE AND PROCESS**

Covering all material legal entities, risk categories, business lines, risks, financial and supervisory reporting processes, and entire data lifecycle
Covering all identified gaps and address any weaknesses
Development of the responsibility, role and risk culture
Addressing all roles and responsibilities, data quality ownership, process, rules and controls
Establishing policies and procedure on overall risk framework
Suppling timely data regarding the frequency of risk reporting
Implementation and documentation of integrated data architecture including data taxonomies


